# St. Paul's Episcopal Church Jackson, Michigan (Unapproved Meeting Minutes) January 24, 2021 (Held online via Zoom)

The Annual Meeting was called to order and opened with prayer by Rev. Sarah at 2:03 p.m. Having established a Quorum present for the meeting, Rev. Sarah then proceeded with the start of the 2020 Annual Meeting for St. Paul's Episcopal Church.

The Unapproved 2020 Annual Meeting minutes were submitted for approval.

A correction was brought to the floor that on the top of page 5 where it listed the rector's discretionary fund at an amount of \$1,500.00 – the fund total should have actually indicated \$15,000.00 Motion was made by Joe Lathrop to approve the 2020 Annual Meeting Minutes as amended,  $2^{nd}$  by Sandra Kilian.

The 2021 Budget was presented by Marco Shehab:

Marco pointed out the following things with regard to the 2021 Budget:

There are new accounts – Rector and Curate discretionary funds as line items.

Lost revenue showing in investment accounts due to the market.

St. Paul's was awarded a PPE loan in 2020 which will offset payroll, operation expenses, etc.

St. Paul's was awarded again a PPE loan for 2021.

Expenses added for Curate salary showing amount paid and payroll. The diocese will reimburse 50% of the cost.

Kitchen wages are now being shown for Jeremiah.

Expenses for internet and camera are up to due updates in the systems.

There are budgeted items for upgrades to the computers.

The office expenses are up due to the purchase of hand sanitizer and equipment to keep up with COVID cleaning protocol.

Postage expense is up due to updated system and the fact that there are more items being mailed out to parishioners.

Bank charges are down as St. Paul's left the bank that was charging us a monthly maintenance fee.

There was no money budgeted for a Choir Director's salary. Due to COVID hitting – no replacement was hired as currently St. Paul's is not able to have in person worship, and therefore no choir.

Marco advised that in 2020 did not have to pull any money from the endowment, however, have budgeted for some withdrawal in 2021 and hoping not to have pull any money.

The floor was opened for Questions --- There were no questions.

Rev. Sara advised those present at the Annual Meeting that they are always looking for persons interested in serving on the Finance Committee. If anyone is interested in doing so, please reach out to her.

Candidates for Vestry were read: Jan Osborne, Barney Rudolph and Elaine Themm

With the early departure of Chuck Sinclair from the vestry, Dennis Marsh is taking over the remainder of Chuck's term on the Vestry. A vote was held to accept the slate of Vestry Candidates as presented – passed by unanimous vote. An Alternate to the Vestry will need to determined.

Vestry members going off the Vestry are: Michelle Gibson and Margaret O'Connor as well as Clerk – Janet Hughes.

A Slate of Delegates for the 2021 Annual Convention were presented:

A vote was held to accept the slate of Delegates for 2021 Annual Convention and Alternate as presented, passed unanimously.

Rev. Sarah presented the following information regarding online shares, etc.

Zoom services showed 30-40 screens participating; while the recorded Zoom & reposted services had 86 engagements

Average Sunday in person service @ 9:00am was 12 (Maximum 30 outside)

Average Sunday attendance 10:30am in person service 43; plus 90 Facebook viewers.

Facebook live -- 177 engagements

Compline online - average 45

Christmas Eve showed 246 combined views with the pre-recorded and late service live stream.

Ray Hartsuff's funeral on 9-11-2020 had 100 attending the cemetery and 426 viewers on Facebook live.

Melissa Congleton thanked St. Paul's for the privilege to be with us and gave shout out the Youth and the Church School teachers. During the coming year the youth of St. Paul's are hoping to continue their activities with the First Presbyterian youth.

Michelle Gibson thanked everyone for the opportunity of serving as Senior Warden on the Vestry. Rev. Sarah gave thanks to Deb Batchelder for her services as Jr. Warden

I cannot tell you what a relief it is to be the rector of a congregation who believe in being vaccinated. The devastation of the hospitals being totally overwhelmed with a majority unvaccinated population is almost beyond belief. My prayers and unending thanks to all of our medical professionals who work day in and day out at their own risk to provide care for all of us.

We did have our share of losses this year with dear parishioners passing on to greater glory in Christ. Since our last Annual Meeting we have lost Beatrice Julian, Jean Laughlin, Bruce Lyons, Sparry Sparks, Shirley Mae Hammond, Doris Easter, and Beth Reynolds. Our prayers are with their families, and we rejoice through our sorrow that they are home with God.

So much has changed and continues to change in how we and the whole world works. Our ministries are vital and yet they are changed as well. After years of faithful service, Kyle King has stepped down as our Buildings and Grounds chief. His shoes will not be filled by one person, but rather a group of people who will work together to make sure repairs and maintenance of our wonderful physical plant continue on. We are always looking for folks willing to help on the B&G Team so please contact us if you are interested.

We were thrilled to have the Get Real Program back again last Summer and to take the kids to Silver Beach in St. Joe to have a day at the lake and just get to play together. My prayer is that our partnership with this program, specifically with the kids and their mentors, grows this coming year so they know how much we love them. Heidi Lathrop and I met several months back to see how we could continue to support the local ministries we do without our old Mission and Outreach model. We were able to financially support many organizations in our community, as well as work with the vestry to discern a true focus on community partnerships built on relationships. More to come this year on that front.

We are currently engaged in our latest community support ministry partnering with the Jackson Interfaith Shelter to provide an overnight warming center on our coldest nights. Every night we're open folks come in off the street to food and a warm, safe bed. Already, officials with the City of Jackson have approached Steve Castle, JIF's CEO to look at ways the City can help with our street population. After years of Steve and I scratching our heads

each winter about who is doing anything for those on the street during winter, we decided to just go for it and let the Lord take this ministry where it needs to go. God willing, we will create even more partnerships in the community to help others and recognize this work as the calling of all of Jesus' Disciples. I'm so thankful to be asked to join the Interfaith Shelter board and look forward to what we can do together in 2022.

Our worship is such a vital and central part of who we are as a church, and I am so glad to see so many of you in person and online each week! We signed a letter of agreement with Julie Baglien making her our permanent organist and are so grateful for her talents, drive and great collegiality. The position of Choir Director will be filled in the coming months so we can begin to build a choir again and hopefully get new members to help us add choral music again to our Sunday worship. None of this would be possible without our new ad hoc Human Resources Team who Zoomed together to help me do the work of hiring and supporting our employees. Joe Lathrop, Debbie Batchelder, Michelle Gibson and Tom Holsinger-Friesen have been wise helpers in these important matters.

I am grateful for 18 months of service alongside the Rev. Melissa Congleton and have been amazed at her adaptability during all the iterations of Sunday School and Youth programming we've been through in that time. What a crazy time to start ministry! Our kids continue to be such a precious part of our community and their parents are heroes for the work they have done in keeping them safe, educated and loved. We are so glad to partner with them in loving all the St. Paul's kids! We hope next month to reprise our sledding party of last year at Cascades Park Hill. What fun it was to bring our families together with families from partner churches for a day of fun outside. Next month we hope you'll join us in an all-St. Paul's Talent Show at coffee hour on Feb. 27<sup>th</sup> (restrictions permitting). Brush off your talents and join us!

The life of St. Paul's church family is rooted in worship and learning and we're reaching out into the community more and more. This past year we watched "Traces of the Trade" learning about the slave trade in New England and the Episcopal Church's deep roots in this barbaric trade. We will have several opportunities as a congregation to learn with our diocesan brothers and sisters about historic and current racial struggles and the efforts of our Church to acknowledge the past and address inequities all around us today. Please, please don't miss this opportunity to read and learn, and please know your clergy and teachers are here to walk this journey together with you and all of us together. Jesus is walking with us too and shouldering a bigger burden than we ever could. My hope is that next Fall we will embark on a parish wide course of the Church-Wide curriculum "Sacred Ground". Only through real and honest conversations on race will we be able to move forward into wholeness together. A suggested reading list will appear soon on our website and bulletin board for your perusal. Please take the opportunity to join in learning this year.

As we look to this New Year, I am so glad for new vestry members, strong pledges and most of all, strong relationships built both within and outside our walls. If we reach out and learn about our neighbors and find out how much we have in common God will help us make this community better together. As we pray for the Kingdom of God to come on earth, we also work to make that Kingdom a possibility through loving our neighbor as ourselves.

Every day this year I ask you to pray for God's guidance for your personal walk with Christ, and guidance for St. Paul's role in changing Jackson to look more like God's Kingdom or as Martin Luther King Jr. called it, God's Beloved Community. Together and by God's Grace, we can make a better community for all. Thank you for the opportunity to serve alongside each and every one of you.

#### **Curate's Annual Report 2021**

Dear Siblings in Christ,

Despite the challenges of living the majority of 2021 with the world in a stage of pandemic, St. Paul's has persevered. While there have been so many challenges those were most often met by blessings, many of which were unanticipated. These blessings kept us grounded as we worked as a parish community to live and be in ways we have never experienced or done before. We have continued to be a parish community and not let the anxiety and fears keep us down. Those blessings kept pointing us back to our rooted faith in God who has continued to journey closely with us in a challenging time. I will touch on a few highlights from this year despite the continued limitations of the pandemic.

I started out the year as a newly ordained transitional deacon and on June 12 Bishop Perry ordained me to the priesthood. It was especially meaningful to me that this ordination was done at St. Paul's. St. Paul's has continued to lift me up in utilizing my gifts in order to work as Curate. The parish continued to receive funding from the diocese to support half of my salary and benefit package as part of the curate program.

Much of my time has been spent coordinating and planning for our children and youth, with the help of other parishioners and parents. In addition to coordinating church school, we had several successful events geared toward young families. The annual Epiphany pageant tradition in January continued in pandemic style, with families acting out scenes and home which were compiled to tell the story electronically. A total of nine families participated in the virtual pageant. In February we went sledding at Cascade Park with the young families from Jackson First Presbyterian Church (JFPC). Conditions were great for some very fast trips down the big hill. March included a trip the Ella Sharp Museum and planetarium. In April we made seed bombs with JFPC to celebrate Earth Day and give back by planting them for others to enjoy. And in early June the Randall's hosted an end of the school year barbecue for the young families to enjoy. The weather was wonderful, and the trampoline, pool and yard games meant fun for all, as well as a time for our parents to connect.

In the summertime we combined with Jackson First Presbyterian Church (JFPC) to host a church a summer art camp. These sessions had our children and youth cardio drumming with Dee Hurlbert and painting self-portraits with local artist Sheryl Amburgey.

Fall arrived and in October we did a second annual Halloween trip to Meckley's Flavor Fruit Farm and in November we started a new partnership with JFPC and First United Methodist Church and came together for a movie night.

All in all, we came together for fun, for learning, for service and fellowship as the pandemic would safely allow.

Looking ahead I see a year with much to look forward to. Our children and youth continue to inspire me to make the best out of the situation we are currently living, and scripture tells me that all will be well with God at our side. As we move into 2022, I invite you to join me as I look forward to living out all that is contained in the hope that I see lived out regularly by our children, youth, and young families.

#### Sr. Warden Report

#### **Church School Annual Report**

#### Grades 1-3 report by Kim Perlos:

Our younger students continue to learn and grow in the ways of God. We are still using the SparkHouse Whirl Kids curriculum and the kids still love it. The videos are so engaging, and the children can relate to what is going on. It is user friendly and teaches concepts in ways children can understand and build on. I love teaching them so much as I learn so much from them. I hope you will keep them in your prayers as they continue to grow in the Lord.

#### Grades 4-6 report by Tom Holsinger-Friesen:

I've been blessed to teach our St. Paul's children who are in the middle-age range. What an energetic, curious, and compassionate group! It's exciting for me to see the ways that these kids are being mentored in the faith by our church as a whole, through the encouragement and kindness they receive from you all each week. In our church school lessons, we began the year 2021 on Zoom. Our common textbook, Stamped, led to a lot of good discussion about how we as Christians can work toward recognizing and overturning racial injustice. We then began a curriculum that followed the church lectionary, giving us the opportunity to look at the same readings we hear in Sunday worship, but from the perspective of the concerns of young people. In the fall, we began a new curriculum under Pastor Melissa's guidance: Journey to Adulthood/Rite 13. This excellent curriculum is well-tailored to the maturity level of the kids. We've been exploring foundational topics such as: What does it mean to be "made in God's image"? What is prayer? We study and discuss pertinent biblical passages and catechism from the Book of Common Prayer, and we have projects to bring ideas to practical application. Faith is growing in the hearts of our children!

#### Grades 7+ report by Pastor Melissa:

The oldest group of kids finished up the Confirm Not Conform Confirmation curriculum. This led them to learning about ministries in the church, doing a service project, and learning with and by mentors. Ministries the youth participated in were technology team, acolytes, lectors, and intercessors. They group also put together a meal for the Interfaith Shelter residents and local poor by preparing it under the guidance of Chef Jeremiah. After preparing the meal the youth served it at the shelter and had an opportunity to meet some of those they served.

Another piece of the Confirmation preparation was working with mentors. Heidi Hosler-Lathrop, Nathan Randall and Ron Rowley stepped up to be mentors for the youth as they prepared for Confirmation. They helped the youth pick a section of scripture that was meaningful to memorize as part of their preparation. In preparing for confirmation the youth met with Pastor Sarah and Pastor Melissa to recite their bible verses, talk about being confirmed, and the chance to ask any questions.

Clearly one of the highlights of the program year was Confirmation for three of our youth at St. Barnabas Church in Chelsea. Due to the pandemic the event was held outside under a large tent with Bishop Perry presiding. It was a very meaningful time for this group of three youth who had been preparing together for two years.

## The Women Of St. Paul's Episcopal Church Annual Report For 2021

The Women of St. Paul's ECW (Episcopal Church Women) group is affiliated with the ECW of the Diocese of Michigan and the Episcopal Church USA. The group serves as a place of spiritual renewal, fellowship, learning and outreach for the women of St. Paul's Episcopal Church and their friends. We also serve the children and youth of the parish as well as support the needs of the altar guild and chancel area of the church. All women of St. Paul's are welcomed and encouraged to fellowship and work with us to serve their own needs and the needs of our parish and community.

The year 2021, just like 2020, offered some unusual challenges. We were unable to meet for the first six months of the year due to Covid concerns. However, July found us able to meet in person thanks to the Covid vaccines. We had a wonderful reunion luncheon at the home of Cheryl Gumper and had 25 women attend. It was a delight to see everyone. August was our month off and we met again with a regular business meeting in September. Board members were elected, and the bylaws were updated. Sandra Kilian,M.D. presented an update on Covid in October and Wendy Clow from Habitat for Humanity presented in November with an overview of the new homes being built on the corner of Franklin and Mechanic. We returned for our annual Christmas luncheon to the Country Club of Jackson in December.

Board members are Sandra Kilian, President, Valerie Rowley, Vice-President, Cheryl Gumper, Treasurer, Christie Swanson and Romelle Frey, Members-at-Large, and Peggy Wilds, Diocesan Liaison, and Janet Wesch, Exofficio member and former president.

We donated \$250 to Habitat for Humanity and will donate \$250 to SOAR after their presentation in April,2022. We sponsored a collection of hats and mittens, toys and personal supplies for Priceless Gifts from the congregation with an overwhelming response. The nut sale was held again this year and is still ongoing with full profits still pending. On December 4, our children were treated to a St Nicholas Party and treat bags. We also recognized our church staff members with a monetary Christmas gift for all of their hard work for the parish.

We continue to sponsor the Aumbry candle in memory of women who have passed away during the year, the altar flowers in June in memory of women who have gone before us and the first Sunday in August in recognition of Rev. Sarah on the anniversary of her calling to St. Paul's. We also contribute to the poinsettia purchase at Christmas time.

#### **Annual Report of Buildings & Grounds for 2021**

Notable mentions for 2021 are as follows:

The outside spring clean-up was performed on 4/10/21 and mulch was added. Floor cleaning equipment was purchased (under Acct.# 6380 Capital Improvements & Equipment) for protecting our floors & hallways. The spring preventative maintenance performed by our contractor Aladdin, found a hole in one of the two heat exchangers above Holy Spirit Hall. Replacement costs were not a planned expense. In the prior year (2020) the heat exchanger failed on the other unit. Both lasted approximately 20 years. These RTU's (Roof Top Units) supply heat and cooling for HSH. Preventative maintenance on all heating and air conditioning equipment is performed under semi-annual contract by Aladdin. These contracts are submitted by Aladdin to St. Paul's for approval twice a year.

The lighting in Holy Spirit Hall has been converted to LED lamps. Of the 96 ceiling lamps replaced, 25 were burnt out. These new lamps will be more energy efficient and last many years.

Flat roofs at St. Paul's cover everything except the "church". The offices and educational buildings were built in 1965, over 55 years ago, Holy Spirit Hall's flat roof is 16 years old. Some sections have been replaced in the last few years, i.e., between the south tower and the glass narthex, however most work repairing leaks have been patch-work. The outside fall clean-up was completed in time for the city leaf pick up.

A request was made this past year for an updated estimate to complete the original plan of construction from back in the early 2000's replacing Camp Hall. Cunningham Construction Co. who did the original work, quoted \$3,300,000.00 with a contingency built in of \$100,000. However, with continuing cost increases in the building market it could cost more.

We have a new contractor for snow plowing. They will not do any shoveling of snow, only plowing. A new snow throwing machine was purchased thru Hammond Hardware in Jackson. Hammond's has a service department and will do preventative maintenance as needed. They do pick-up and delivery also.

The numbers thru November 2021 for Buildings and Grounds are listed as \$8,833.84 over budget to date. The overage can be related to unforeseen expenses with heat exchanger replacement, flat roof repairs and calls to Aladdin for no heat/cooling in the church. As of this report the new heating and cooling systems are installed and functioning.

#### "So How Are The Numbers?"

During pandemic it's not easy to count accurately the amount of folks worshipping with us online. This struggle points to our emphasis on raw data as a mark of "success" without a focus on the stories, lives and relationships that data represents. I took a look back to give you a snapshot of how many folks attended our online worship in 2021.

We were able to use our Facebook live stream (managed by our fantastic Tech Team) each Sunday of 2021 and for several other special services as well. Facebook counts page interactions, but these engagements have no specified duration and are from anyone who happens upon our page whether a member or not. It's a fascinating Evangelistic tool!

Those who want to build a plan or policy around data are frustrated in their attempts to make meaning out of these numbers. My role as your pastor and priest is about relationships and I am happy that during 2021 folks took time out of raising their kids, dealing with their health, job loss and transition and deaths of friends and family to spend time with God and with us! So however you want to look at our "numbers" here is a sample of those:

ASA (Average Sunday Attendance) for 8am In-Person Worship: 13 ASA for 10:30 In-Person Worship (42 weeks in person): 41 Facebook Live: 177 Average Att. for Wed. In-Person Eucharist (42 wks in person): 5 Wed. Facebook Compline: 45 avg.

Our highest number of Facebook engagements in 2021 was for St. Patrick's Day Sunday with special Irish Music

Christmas Eve In-Person for 2 services was 143 with Facebook engagements at 66. The single best attended Sunday service was on Oct. 31<sup>st</sup> with 91. The largest number for any service was for Sparry Sparks' funeral at 170.

I hope this helps answer some of your questions and I'm happy to speak to any of you about it. Our engagements are increasing as news gets out about the Warming Center we offer. Folks are attracted to our <u>actions</u> in the name of Christ more than our <u>words!</u> Our membership is strong and our evangelistic outreach through social media has blown me away! We don't count all these engagements as members, but our reach is spread far, and we have gained unique tools and insights in how to further our call as disciples. Thank you for all your support!
